ASL Regulations

General information

- A.1 These are Challenge League Match Play golf rules where players earn points by playing any number of 18-hole matches during the Regular Season.
- A.2 The Regulations apply to the following competitions:
 - a) Match Play Open League of Golf (Otwarta Liga Golfa) 2023 Edition (hereinafter "OLG") FREE participation
 - b) All-Square Match Play Golf League 2023 Edition (hereinafter "ASL") paid participation
 - c) others reported to the Website, accepting these rules in the Regular Season phase (relevant statement required) participation under the conditions set out by the organizers of the club or friendly league.
- A.3 A player's admission to OLG is subject to registration on the Website. The OLG classification is carried out in the Open Table.
- A.4 The condition for admitting a player to ASL is registration on the Website and payment of an activation fee in the amount of PLN 200. The ASL classification is maintained in the ASL Table.
- A.5 Players agree the time and place of the match themselves, e.g. on the Website available at https://asl.golf or via the fb group.
- A.6 Matches may be played domestically and internationally on any golf course with a current calibration at any time during the Regular Season.
- A.7 Regular Season matches are played in the Net Match Play system (for holes won) with **3/4 of the Course HCP difference**, in accordance with the R&A Golf Rules and golf etiquette.
- A.8 The competition is open to an unlimited number of players.
- A.9 Registration should be made electronically on the Website available at https://asl.golf at any time until the end of the Regular Season Q&A via the e-mail address asl@asl.golf.

A.10 The Regular Season lasts until 12:00 p.m. September 22, 2023.

- A.11 The first place finisher in OLG at the end of the Regular Season will be named the Match Play Open Golf League Champion 2023 Edition.
- A.12 The best 32 players, according to the final classification of the ASL Table, will receive a promotional invitation to the 2-day Final Round, which will take place on October 7-8, 2023.
- A.13 The Regular Season standings include:
 - a) individual matches (Singles)
 - b) matches in the Foursome, Four-Ball and Greensome formula (enter the result of the match with only one player!)
 - c) matches in pairs (we then add up the Course HCP of each pair, play with a difference of 3/4 of the Course HCP and add up the result of the pair to the result on the hole enter the result of the match with only one player!)

provided that each player is registered on the Website.

- A.14 The results of all registered players will be included in the Open Table, in addition, the results of players admitted to ASL competitions, including matches with OLG-only participants, will additionally be included in the ASL Table. The results of the club or friendly league participants will be included in an independent table of this league, classified depending on the organizer's guidelines.
- A.15 Local rules apply during the games.

Regular Season

- B.1 During the Regular Season, the basis for determining the number of extra handicap strokes is the player's HCP Index at the time of the match, according to the handicap base of any proper golf association (each player should have a valid handicap card).
- B.2 The maximum HCP Index is 36.0. Players with a higher handicap play with HCP Index of 36.0.
- B.3 Playing from any tees (but not higher than allowed by local rules).
- B.4 The extra strokes the player with the higher handicap receives is calculated by taking 3/4 of the difference in the Course HCPs and rounding the result to an integer; in the case of n.25 to n (e.g. 2.25 = 2), for the result n.5 or n.75 to n+1 (e.g. 4.5 = 5) as in the following example:

Player A: HCP Index = 14.9; Course HCP = 18

Player B: HCP Index = 22.2; Course HCP = 27

Extra strokes = 0.75 x (27-18) = 0.75 x 9 = 6.75 and rounded up to 7.

- B.5 Player B receives 1 extra stroke on the 7 most difficult holes of the course according to the Stroke Index (shown on the scorecard). An extra stroke for Player B means e.g. that Player A wants to win a hole with an advantage of Player B must score 2 gross strokes lower than opponent, when a score 1 gross stroke lower means a hole tied (A/S) and with the same number of strokes gross Player A loses the hole.
- B.6 During registration, the player provides his Home course name, i.e. indicates the golf course where he is a member in a given year (in the case of more than one right to play points at only one of them), or in the absence of membership, the golf course where he will most often play matches.
- B.7 If during the Regular Season a match is played on the Home course (visible on the Website available at https://asl.golf) of only one player, the number of extra strokes in the match is reduced by 2 strokes (in the case of the player with the higher HCP Index on his/her Home course) or increased by 2 stroke (in the case of a player with a lower HCP Index on his/her Home course).

For example, if the number of additional strokes resulting from 3/4 of the Course HCP difference is 7, then in the case of a player with a higher HCP Index (e.g. 22.2 as above) playing at home, we reduce the advantage to 5 strokes, and if the match takes place at the Home course of a player with a lower HCP Index (e.g. 14.9 as above), we increase the advantage to 9 strokes. The rule also applies to matches in pairs, as long as the match takes place on the home field of at least one of the players.

- B.8 The winner of the match is the player who wins the greater number of 18 holes. The match is considered settled if the advantage of one of the players is greater than the number of holes left to be played, e.g. Player A after 16 holes played leads by 3 holes (3 up), when only 2 holes remain to be played, the match is therefore settled and ended on hole #16 and the score is 3&2 for Player A.
- B.9 The match may end in a draw, in which case the score of the match is A/S.
- B.10 The result of the match should be entered on the website https://asl.golf in the "Scores" tab. There is no obligation to report a match before it is played. The result must be reported within 7 days from the date of the match.
- B.11 In addition, on the Website available at https://asl.golf, in the "Invitations to the match" tab or on the fb group, information about proposals to play the match can be posted. Players should contact each other in any way (e.g. via the Website, fb group, Messenger, Whatsapp, etc.) and agree on a date and place of the match that suits everyone.
- B.12 Regular Season scoring is based on big points (BP) and small points (SP), as follows:
 - a) A/S = 1 BP (0 SP)
 - b) 1up, 2&1 or 2up win = 2BP (1 SP for 1up and 2 SP for 2&1 or 2up)
 - c) 3&1, 3&2, 4&2 or 4&3 win = 3BP (3 SP for 3&1 or 3&2 and 4 SP for 4&2 or 4&3)
 - d) 5&3, 5&4, 6&4, 6&5, 7&5 or 7&6 win = 4BP (5 SP each)
 - e) 8&6, 8&7, 9&7, 9&8 or 10&8 win = 5 BP (5 SP each)
 - f) loss = 0 BP (-1 to -5 SP as the inverse of the winning player's SP score).

- B.13 For winning the match, the player receives the appropriate amount of BP and SP equal to his advantage. For example, if the match ends 4&3, the winning player gets 3 BP and 4 SP.
- B.14 For a lost match, the player receives 0 BP and as many negative SP as the winner's advantage. For example, if the match ends 4&3, the losing player gets 0 BP and -4 SP.
- B.15 The maximum number of SP in a single match is 5, i.e. if a player wins a 7&6 they will receive 5 BP and 5 SP and the losing player will receive 0 BP and -5 SP appropriately.
- B.16 The Regular Season classification includes matches played according to pt. A.13 above.
- B.17 3 is the maximum number of ranked first matches with the same person in one Regular Season.
- B.18 A minimum of 6 Regular Season matches is required to qualify for the ASL Final Round, regardless of where the final Regular Season standings are placed.
- B.19 It is recommended to write down the results of matches during the Regular Season. Players mark the scores for individual holes on the card and indicate the winning hole, e.g. with the symbols: "+", "-", and in the case of a tied hole, "o". Players' data can be entered on the scorecard, signed and a photo can be sent to <u>asl@asl.golf</u>.
- B.20 The player's best 12 scores count towards the final standings of the Regular Season, and the standings at the end of the Regular Season are determined in order of:
 - a) higher number of big points (BP)
 - b) higher number of small points (SP)
 - c) higher number of wins in the entire Regular Season (also over 20 games)
 - d) a lower HCP Index
 - e) drawing lots.

ASL Final Round

- C.1 The top 32 players will qualify for the ASL Final Round according to the final standings of the Regular Season ASL Table.
- C.2 Participation in the Final Round is entirely voluntary. In the event of refusal to participate in the Final Round or lack of confirmation within the indicated period, the next players from the Regular Season ranking list will be invited to the Final Round until the final pool is full.
- C.3 The Final Round lasts 2 days and will be played on a golf course in Poland or in another Central European country indicated by the organiser. Finals venue will be announced during the Regular Season.

C.4 For players invited to the Final Round we provide:

- a) promotional green fee for 54 holes (4x9 + 18) as part of the Final Round
- b) 2x meal vouchers
- c) an invitation to dinner on the evening of the first day of the Final Round, combined with the announcement of pairings for the Match Play Finals Day
- d) prizes for the best.
- C.5 In the case of special awards or events, the organizer reserves the right to introduce separate regulations for the award or event.
- C.6 The Final Round will be played in a knockout system as follows:
 - a) the Final Round will be divided into 2 groups according to even and odd places according to the final classification of the Regular Season
 - b) seeding in the group bracket in the Final Round will take place in accordance with the final classification of the Regular Season, i.e. 1st place competes with 31, 2nd with 32, 3rd with 29, 4th with 30 etc.
 - c) 1st day is the Moving Day we play 4x 9 holes until the ranking in groups and at the same time pairs on the Match Play Finals Day emerge
 - d) day 2 is the Finals Day played on an 18-hole course, the winners of each group on the Moving Day play for the victory in ASL, and the remaining players compete according to the occupied places, i.e. 2 out of 2, 3 out of 3, etc.
- C.7 The basis for determining the number of extra handicap strokes is the player's HCP Index as at the start of the Final Round, according to the handicap base of any proper golf association. The extra strokes the player with the higher handicap receives is calculated by taking 3/4 of the difference in the Course HCPs and rounding the result to an integer; in the case of n.25 to n (e.g. 2.25 = 2), for the result n.5 or n.75 to n+1 (e.g. 4.5 = 5). The Home course rule does not apply.
- C.8 A match on Finals Day must be settled in Play-Off starting from the 1st hole.
- C.9 In Play-Off, the "Sudden Death" rule applies, i.e. the game is won by the player who first wins the next hole, taking into account 3/4 of the difference in Course HCPs.
- C.10 Players mark the scores for individual holes on the card and indicate the winning hole, e.g. with the symbols: "+", "-", and in the case of a tied hole, "o". At the end of the round, players enter the agreed score and, together with the signatures of both of them, hand over the scorecard to the organizer.
- C.11 Prizes will be awarded to the winners of the Final Round. Prizes and their distribution will be announced during the Regular Season.

Registration for the Match Play Open Golf League (Otwarta Liga Golfa) - 2023 Edition

- D.1 The condition for admission to OLG is registration on the Website https://asl.golf.
- D.2 Eligible to participate in the OLG are amateur golfers aged 15 or over with at least limited legal capacity, holding a handicap card and registered with the handicap database of any relevant golf association on the day of the match
- D.3 For full use of the Website https://asl.golf, it is necessary to register the player, in particular to set up a User Account and then log in to one's own Profile, and then use its functionality. It is through the Website provides information about individual events, arranging matches, reporting results, previews of the current ranking, etc. Therefore, please read the Terms and Conditions of the website, because in order to participate in the league, it is necessary to accept the terms of its functioning.
- D.4 Hence, for full participation in OLG:
 - a) first, please read the terms of use of the Website available at https://asl.golf;
 - b) if you accept the terms and wish to participate in the league: please set up an User Account on the Website;
 After setting up an User Account on the Website the full functionality of the Website will be made available.

Registration for the All-Square Match Play Golf League - 2023 Edition

- E.1 The condition for participation in ASL is registration on the Website https://asl.golf and payment of the activation fee of PLN 200 the payment can be made by bank transfer to the following account: ASL Management Sp. z o.o., ul. Włóczków 20/3, 30-102 Kraków, account number PL91 1050 1445 1000 0090 8217 6695 at ING Bank Śląski S.A. or via the payment gateway at https://asl.golf, in both cases, please provide the player's name and address in order to issue an accounting document.
- E.2 Eligible to participate in the ASL are amateur golfers aged 18 or over who hold a handicap card and are registered with the handicap database of any relevant golf association on the day of the match.
- E.3 For full use of the Website https://asl.golf, it is necessary to register the player, in particular to set up a User Account and then log in to one's own Profile, and then use its functionality. It is through the Website provides information about individual events, arranging matches, reporting

results, previews of the current ranking, etc. Therefore, please read the Terms and Conditions of the website, because in order to participate in the league, it is necessary to accept the terms of its functioning.

E.4 Hence, for full participation in ASL:

- a) first, please read the terms of use of the Website available at https://asl.golf;
- b) if you accept the terms and wish to participate in the league: please set up an User Account on the Website;
- c) after creating an Account, please pay the activation fee referred to at the beginning of this chapter;
- after the payment is credited, within 3 days from the date of receipt of the funds, the player will be admitted to the ASL.
 However, the full functionality of the Website will be made available after setting up an User Account on the Website.

Closing information

- F.1 The organizer of OLG and ASL is ASL Management Sp. z o.o., ul. Włóczków 20/3, 30-102 Kraków.
- F.2 The organizer has the right to cancel the ASL competition, in which case the activation fee will be refunded.
- F.3 In case of disputes, final decisions will be made by the organizer.
- F.4 The organizer has the right to randomly verify the matches played, therefore, entering the course for ASL matches should be reported at the reception desk.
- F.5 The organizer does not accept unethical behaviour. In the event of three independent reports of violation of the R&A Rules of Golf or golf etiquette, the organizer will have the right to disqualify and remove the player from the competition without refunding the registration fee.
- F.6 As part of the complaint procedure and dispute resolution, the provisions of the Regulations of the website apply.

Additional information

- Payment of the activation fee in the amount of PLN 200 allows the player to participate in the All-Square Match Play Golf League 2023 Edition, including the possibility of using the Website available at https://asl.golf and inclusion in the ASL ranking, and also through access to other events related to the league organized by ASL Management sp. z o.o. with its registered office in Kraków, address: ul. Włóczków 20/3, (30-102 Kraków) KRS: 0001027341, NIP: 6772492414, REGON: 524846300, e-mail address: asl@asl.golf - using these contact details it is possible to communicate with the organizer, as well as submit complaints.
- 2. Keeping rankings of other club or friendly leagues and arranging matches is free of charge.
- 3. Possible participation in the next editions of OLG or ASL will require the conclusion of contracts, consents and payment of fees, which will be separately specified in the documents and regulations prepared for the next editions.
- 4. The activation fee allows only participation in ASL, it does not cover the costs of green fee, equipment, meals, accommodation, transport, etc. these costs are covered by the players themselves.
- 5. The activation fee does not include costs related to participation in competitions other than ASL
- 6. A consumer who has concluded a distance or off-premises contract may withdraw from it within 14 days without giving any reason and without incurring costs, except for the costs specified in art. 33, art. 34 sec. 2 and art. 35 of the Consumer Rights Act (ustawa o prawach konsumentów), i.e.:
 - a) if the consumer has chosen a method of delivery of the goods other than the cheapest usual method of delivery offered by the entrepreneur, the entrepreneur is not obliged to reimburse the consumer for the additional costs incurred by the consumer;
 - b) the consumer bears only the direct costs of returning the goods, unless the entrepreneur agreed to bear them or did not inform the consumer about the need to bear these costs;
 - c) if the consumer exercises the right to withdraw from the contract after making a request in accordance with art. 15 sec. 3 and art. 21 sec. 2 (requests to start performance before the expiry of the period to submit a declaration of withdrawal from the contract), is obliged to pay for the services provided until the withdrawal from the contract. The amount of payment is calculated in proportion to the scope of the service provided, taking into account the price or remuneration agreed in the contract. If the price or remuneration is excessive, the basis for calculating this amount is the market value of the benefit provided.
- 7. The deadline for withdrawal from the contract starts from the date of conclusion of the contract, i.e. from the date of payment of the activation fee.
- 8. The consumer may withdraw from the contract by submitting a declaration of withdrawal from the contract to the entrepreneur. The statement can be submitted on the form, the template of which is attached below using the form is not necessary.
- 9. To meet the deadline, it is enough to send a statement before its expiry.
- 10. The organizer will immediately send a confirmation of receipt of the declaration of withdrawal from the contract.
- 11. In the event of withdrawal from a distance contract or an off-premises contract, the contract is considered null and void, i.e. the organizer will return the entire amount of PLN 200 paid as the activation fee and remove the User Account from the ASL Table or, at the express request of the User, remove the User Account from the Website.
- 12. The refund is made in the same way as it was paid, unless the consumer clearly indicates a different method of return.
